

**SUBJECT: LEGAL NOTICE TO DESIST FROM CIRCULATING ILLEGAL COLLABORATION  
AGREEMENT DATED 28.01.2020**

Sir/ Madam,

We write to you on behalf of our client M/s. Terix Computer Services India Private Limited (“**Terix**”) having its registered office at 55, 2<sup>nd</sup> Floor, Lane- 2, Westend Marg Saidullajab, Near Saket Metro Station, New Delhi- 110030, who has instructed us to serve you with the present legal notice as under:

1. Recently, it has come to the knowledge of the management of Terix that you the noticees, Mr. Deepak Joshi, Mrs. Jyoti Joshi and your other accomplices are circulating an illegal collaboration agreement purportedly executed between Terix and TPM Guru Private Limited (“**TPM Guru**”) on 28.01.2020 to the existing as well as potential customers of Terix. In this regard, we state that the abovementioned agreement is fabricated and forged and has been created in furtherance of committing the criminal conspiracy hatched by you the noticees alongwith Mr. Deepak Chandra Joshi, Mrs. Jyoti Joshi and your other accomplices. The said agreement is illegal, null and void and it was neither put

before the Board of Directors of Terix nor was shareholders' approval was sought which was required as Mr. Deepak Joshi and Mrs. Jyoti Joshi were directors in both Terix and TPM Guru as on 28.01.2020. The other directors and shareholders of Terix were totally unaware of existence such agreement, till it was received by Terix from one of its customers as recent as on 08.04.2021.

2. Further, it is evident that the said agreement is made only to divert business of Terix to TPM Guru without making any payment to Terix for either taking its customer or using Terix's manpower and resources. The said agreement has been used by you the noticees, Mr. Deepak Joshi, Mrs. Jyoti Joshi and your accomplices to mislead Terix's customer; which in itself is a punishable offence under Indian Penal Code. Thus, the abovementioned agreement is illegal, de hors law and is a part of the criminal conspiracy hatched by Mr. Deepak Joshi, Jyoti Joshi and other accomplices to enrich themselves unlawfully by causing huge financial losses to Terix.
3. In view of the above, you are hereby directed not to circulate the abovementioned fabricated and forged collaboration agreement dated 28.01.2020 to any third party with immediate effect, failing which, we have definitive instructions from Terix to initiate appropriate legal proceedings against you under criminal as well as civil law at your cost and expense.

This notice is being issued without prejudice to the rights and contentions of Terix.
